

Sir,

This has reference to your application for recognition of Associate Membership Course equivalent to degree & Technician Membership Couse equivalent to diploma awarded by IET (I), Kolkata.

In this connection, it is to be noted that awarding equivalence to any programme is not come under the purview of Distance Education Council (DEC). It is the Association of Indian Universities (AIU), New Delhi who give equivalence to the degrees.

Further, subsequent to the order of MHRD dated July 29, 2009 directing DEC to withdraw permission, if any, from all Universities/ Institutions offering B.E./ B. Tech. Engineering course through distance mode in compliance to that, DEC has written to all Open and Distance Learning (ODL) providers not to offer B.E./ B.Tech. programmes through Distance Mode and also asked them to ensure that no student is admitted from the year 2009-2010 onwards.
